Inmates can release their personal property within 8 BUSINESS DAYS and must fill out a Property Release on the Inmate Kiosk in their cell. You must have proper identification to pick it up. *We do not release their clothing.*

WAYS TO COMMUNICATE CONTINUED

This service is activated by the friend/ family member, but the inmate can send you an invite from the machine in their cell.

- Once your Visitor Account is approved by Jail Administration (which could take up to 48 hours) you will be allowed to request a visit with an inmate.

VISITATION SCHEDULE

- REMOTE VISITS (made from your cell phone or computer) are allowed any day of the week 7am to 11pm as long as the inmate kiosk is available.
- ONSITE VISITS (made from the kiosks in the Detention Center Lobby for FREE) are the following days:
 - TUESDAY 3 PM – 5 PM
 - WEDNESDAY 9 AM – 11AM
 - FRIDAY 3 PM – 5 PM

Onsite will be cancelled in the event there is a court scheduling issue, or if Admin is closed due to holidays, etc.

They must be scheduled a day in advance by calling the Front Office @ 526-1002 ext 24
